LUNT Solar Systems LLC reserves the right to change product specifications or to discontinue products without prior notice. LUNT Solar Systems LLC reserves the right to replace any products, which has been discontinued from its product line with a new product of comparable value and function.

WHAT IS NOT COVERED

This warranty does not extend to any product whose serial number has been defaced or altered, or to any product which LUNT Solar Systems LLC determines to contain a defect or malfunction caused by damage while in the possession of the consumer, this includes de-contacting of etalon. De-contacting of the etalon only occurs if the product is subjected to shock, i.e. dropped and/or banged. The above descriptions may include incorrect installation, maladjustment, misuse, negligence or servicing by the consumer, or by a failure on the part of the consumer to provide reasonable and necessary maintenance.
